## **MEMBERSHIP CATEGORIES AND FEES**

### **Active Stockholders**

\$450

Homeowners who hold shares of stock and whose dues payments are up-to-date. A \$50.00 discount for senior households of 65 and older is applicable.

## Inactive Stockholders

Homeowners who hold shares of stock who only want to keep their dues payments current. Families paying by the due date will receive 10 guest passes. Each pass is valid for one person's use of the pool for one day. Senior discount not applicable. Inactive Stockholders can purchase a grandparent pass for \$125/week. The grandparent pass is intended for inactive members that want to visit the pool with friends or family visiting from out of town. We will also be offering guest passes to be purchased for \$10 each. They cannot be purchased at the gate. Please contact Kristin or Karen for more information.

#### Resident Non-Stockholders \$550

Families, who own homes within the boundaries of the neighborhood as defined in the by-laws, but do not own pool stock. A \$50.00 discount for senior households of 65 and older is applicable.

## Non-Residents \$650

Families who live outside the boundaries of the neighborhood as defined in the by-laws and were members of the pool the previous calendar year. Please note: these memberships are offered on a first-come, first serve basis, if space is available after receipt of the stockholder and resident memberships. A \$50.00 discount for senior households of 65 and older is applicable.

<u>Member Referral Program</u>-Active members may refer a new member to the pool and receive 10 free guest passes. New members being referred will receive \$50 off of their membership. (only available to new members of the pool).

#### **Purchase of Shares**

Pool shares can be purchased on a three-year installment plan. The cost of the share is \$500. Under the installment plan, one third of the share cost (\$167), plus the annual active shareholder dues (currently \$450), is due each year for three years. Shareholder privileges begin with the first installment payment. Eligibility to purchase shares is determined by neighborhood boundaries. If you have any questions, please contact a membership committee member.

## Membership:-

A 2024 membership form is enclosed. Send your completed membership form and payment, postmarked up to and including the due date (to receive your complimentary guest passes).

We are happy to report we continue to have increased interest in pool membership from inside and outside the neighborhood. Your prompt response to this mailing will increase your chances of receiving a membership. Per our By-Laws, we can accept only 275 family memberships. If your membership form is not postmarked by April 15<sup>th</sup>, we cannot guarantee you a membership to the pool.

**Pre-Purchased Guest Passes.** Pre-purchased guest passes are available to all **ACTIVE** members at a rate of 20 passes for \$85 or 10 passes for \$45. A limit of 20 passes can be purchased at the beginning of the season. These passes are non-refundable. All guest passes are non-transferable between purchasers and other pool members. Please indicate the amount on the registration form and these will be placed in your membership packet. Guest passes may not roll over year to year.
